## Le contexte

L'avocat international et le juriste international d'entreprise inscrivent leur action dans un contexte d'affaires qui requiert la maîtrise des questions juridiques et la compréhension des enjeux politiques, économiques, financiers et sociaux du monde moderne. Franchissant les barrières linguistiques et culturelles, ils peuvent dialoguer avec des partenaires, juristes ou entrepreneurs de culture étrangère, en vue de proposer des réponses opérationnelles et adaptées à la mondialisation du droit.

## The business context

Successful international business lawyers require not only mastery of legal issues, but also understanding the political, economic, financial and social issues of the modern world. Overcoming the linguistic and cultural barriers, they can dialogue with partners, lawyers or entrepreneurs of foreign culture, in order to propose operational responses adapted to the globalization of Law.

**Un parcours en langue anglaise, à Paris puis à Londres ou à Sydney, pour se préparer à l'exercice du droit international des affaires**

**Un parcours innovant** Pour faire face à ces enjeux juridiques, économiques et sociétaux, une formation complète et actuelle des jeunes juristes d'affaires doit comporter, à côté d'enseignements approfondis en droit, des ouvertures sur les disciplines du Management, les enjeux des nouvelles technologies et une réflexion sur l'action du juriste en quête de sens.

**Un partenariat d'envergure** Dans cette perspective, l'Institut Catholique de Paris s'associe à Saint Mary's University Twickenham London et à Notre Dame Australia University pour proposer aux étudiants un parcours enseigné en langue anglaise en deux ans, à Paris en 1<sup>re</sup> année, à Londres ou Sydney en 2<sup>e</sup> année. Le programme du Master couvre les principales questions juridiques sous l'angle européen et international, tout en donnant aux étudiants les clés de compréhension de l'environnement des entreprises, ainsi que des repères culturels indispensables à un environnement des affaires mondialisé. Après la première année à l'ICP, au cœur du Paris des Universités, des grandes institutions et cabinets d'avocats où le droit s'élabore quotidiennement, la seconde année se déroule entièrement sur le vaste campus de Saint Mary's, à quelques minutes du centre de Londres, ou en plein centre de la très moderne Sydney. Les étudiants y vivront une expérience culturelle internationale unique, tout en profitant de deux villes exceptionnelles.

**Un enseignement de haut niveau** Les enseignements sont dispensés par une équipe réunissant des professeurs de l'ICP, de St Mary's, de Notre Dame Australia et des avocats praticiens du Droit international des affaires à Paris, Londres et Sydney, l'ensemble du programme étant placé sous le contrôle d'un comité d'orientation composé de représentants de cabinets internationaux d'avocats et de directeurs juridiques ou fiscaux de grandes entreprises.

**Un double diplôme à la clé** Au terme des deux années d'études, les étudiants obtiennent un double diplôme : un master 2 de droit, diplôme d'État en convention avec l'Université de Poitiers, et un LLM de Saint Mary's University ou un LLM de Notre Dame Australia, soit un diplôme français et un diplôme britannique ou un diplôme australien, qui leur ouvrent les portes du monde professionnel du droit international des affaires.

An integrated programme, taught in English in Paris, London and Sydney, to prepare for the practice of international business law

**An innovative path** In order to face these complex and interconnected issues, a complete and up-to-date training of international business lawyers must include, alongside in-depth lessons in law, exposure to the disciplines of management, the impact of new technologies and a reflection on a lawyer's response to ethical questions.

**A key partnership** With this in mind, the Catholic University of Paris is partnering with St Mary's University London and Notre Dame Australia to offer students a two-year course in Paris and London or Sydney, taught in English. The Master's program covers the main legal issues from a European and international perspective while giving students the keys to understand the business environment, as well as cultural benchmarks related to the globalization of business. After the first year at ICP, in the center of Paris, the second year takes place entirely on the St Mary's campus or the Notre Dame Australia campus, where students will experience a unique international cultural experience.

**High quality teaching** The courses are taught by a team of professors from ICP, St Mary's and Notre Dame Australia and international business law professionals (Paris, London and Sydney). The entire program being placed under the control of a steering committee composed of representatives of international law firms and legal and tax directors of large companies.

**A double degree** At the end of the two years of study, students obtain a double degree: a Master in Law, State degree according to the convention signed with the University of Poitiers and a LLM from St Mary's University or Notre Dame Australia, a French diploma and a British or Australian diploma, to help open the doors of the professional world of international business law.

EDUCATIONAL TEAM

The Master's courses were designed in a two-year continuum, by a team of French, British and Australian teachers, to ensure the coherence of the educational project.

They will be provided in Paris, London and Sydney by academics and legal practitioners working in close collaboration with programme leaders and guidelines of the steering committee.



**Philippe Corruble**, HEC graduate and Doctor in Law, is Professor at the Catholic University of Paris where he teaches European competition law, having taught this subject at HEC Paris and in various foreign universities, notably in Saint Gall (CH). He received the Vernimmen Prize awarded to the best professor of HEC. Along with his academic activities, he worked at the DG Competition of the European Commission and in various international law firms, in Paris and Brussels. As a lawyer, he currently practices in the international law firm STREAM.



**Dr Thompson** has enjoyed a wide and varied career in law with experience in property, commercial, international, constitutional, criminal and human rights law. He worked for 11 years in Auckland in commercial and property law including 6 years as a partner with Fortune Manning. Since returning to Australia in 2011, he has been appointed as professor and associate dean at the university of Notre Dame Australia's Sydney school of Law where he teaches constitutional law, law and religion, evidence and legal history, but he retains an interest in legal practice.



**Aurelien Portuese** is an expert in competition law & economics and research on application of antitrust rules to the digital economy. Doctor in law from the University of Paris II Pantheon-Assas, Aurelien Portuese is Senior Lecturer at the St Mary's Law School of St Mary's University Twickenham London. French qualified lawyer (Paris Bar), he has published extensively on competition law, EU law, and more generally law & economics. Affiliated scholar at the International Center for Law & Economics, Aurelien teaches EU law, competition law, international economic law and he is currently working on a research project on "Antitrust populism".



**Arnaud de Nanteuil** is Professor of International Law at the Paris Est Créteil University (Paris 12) and Associate Professor at the Catholic Institute of Paris. He teaches mainly public and economic international law. He is the author of the only French textbook devoted exclusively to international investment law, which has been awarded by the Institut de France and he is also the author of a large number of contributions in this field. He also advises on arbitration and investment law, for private or state entities.





**Opi Outhwaite** is Senior Lecturer in Law at St Mary's University. Opi's main teaching and research interests are centered around international law and governance particularly with reference to the environment, human rights and international business operations. She has undertaken research as part of an international collaboration to develop the Electronics Watch model for improving labour conditions in the global electronics supply chain. She is co-editor of the IUCN Academy of Environmental Law Journal. Opi is in charge of the Master of Globalization, Law & Justice and International Affairs and Ethical Challenges.



**Pierre Kirch** is a partner in the litigation department of the multinational law firm Paul Hastings (Paris and Brussels Bars). His practice has focused on competition law but has also spanned the broad range of corporate/M&A, and commercial litigation/arbitration international disciplines. In recent years, and on a *pro bono* basis, he has litigated, on behalf of the London-based NGO ClientEarth, before the European Courts in Luxembourg. In the area of freedom of expression, for the Paris-based NGO Reporters without Borders and again on a *pro bono* basis, he directed a team of 70 lawyers which drafted, the «Defense Handbook for Journalists and Bloggers» (winner of the Thomson Reuters Foundation Trustlaw Collaboration Award 2015).



**Dr Peter Williams** Prior to joining UNSW in 1993, Peter worked for 14 years in the private and public sectors, including the planning and urban research consultancy firm plant location international (Australia) PTY limited, the land commission of NSW, National Parks and Wildlife service, the land and environment court and the department of mineral resources. For over 25 years he has contributed to research in the field and has served on several state and local government committees.



**Dr Greg Walsh** Greg Walsh was educated at the Australian National University where he completed a combined bachelor of Laws/Science degree and a graduate diploma in Legal practice. He completed a master of Laws degree at the University of Sydney and a doctor of Philosophy degree at Curtin University. He has lectured at Western Sydney University and the University of New South Wales. Greg has worked in various legal roles in Australia and overseas, including working for the office of the director of public prosecutions, the medical negligence department of Maurice Blackburn lawyers, and the office of the United Nations high commissioner for human rights.



**Rosina Dyke** holds an LLB in Law with French Law from University College London (UCL), which involved three years of study in London and an Erasmus year in Aix-en-Provence. She is qualified as a solicitor of England and Wales. She trained and started her career in a US law firm in London, specializing in mergers and acquisitions and capital markets. Following a spell working in-house at an insurance company, she moved to Paris to work in the yachting department of a UK based law firm. She currently works for international firm HFW, focusing on sale, purchase, financing and other general yachting transactional matters, as well as commercial maritime financing.



**Lloyd Gash** is a Solicitor of the Supreme Court of England & Wales and brings into his teaching role over seven years' post qualification experience as a practising dispute resolution specialist. Lloyd joined St Mary's in 2015 to pursue a passion for legal education teaching International Trade Law, Insurance Law and Work Based Learning for Law. Drawing on his strong links with private practice, Lloyd provides careers advice to students as well as acting as mooted coordinator. Recognising the importance placed on commercial awareness as a graduate attribute, Lloyd designed, implemented and continues to deliver an innovative Commercial Awareness seminar series open to all law students at St Mary's.



**Gianmarco Monsellato**, graduate HEC, lawyer, directed Taj, one of the largest French law firms, from 2004 to 2016. Senior Partner of Deloitte, he is also Director of the European Tax Policy Center where he represents Deloitte to the European Institutions, especially on issues related to the future of taxation. Gianmarco has more than 20 years of experience in international taxation and transfer pricing. He advises major French groups on their global tax policies and defends major foreign and French groups in their tax litigation. He chairs the French Tax Committee of the International Chamber of Commerce and is a member of the International Fiscal Association and the European American Chamber of Commerce (France).



**Dr Ulysses Chiaotto** holds adjunct professorships at Western Sydney University, the University of New England and the University of Notre Dame Australia. He earned his Doctor of business administration degree at the University of South Australia and holds MBA, LL.M and LL.B degrees from respectively, the University of New England, the University of Sydney and Macquarie University. After working as an Asia-Pacific director at Deloitte Touche Tohmatsu, he established his own SSAMM management consultancy and has continued to advise multinational corporations, not-for-profit institutions and global fund managers.



**Martine Rossetti** After spending ten years in initial training and in corporate tax advice, Martine Rossetti joined Francis Lefebvre Professional Education and Training in 1998, as head of the Tax department. She is also adjunct Professor at HEC Paris, in the Law and Taxation Department.



**Luke Mason** Dean of the Law School at Birmingham City University, Luke is a philosopher, lawyer and social theorist. He has taught law, philosophy and social policy in many universities in the UK and abroad. Luke's main areas of education include the philosophy of law and legal theory, labor law and the law of the European Union. He won several awards for teaching, including in 2014 the renowned national award "Law Professor of the Year". It plays an active role in developing strategies and policies for legal education and training at university and national level. Luke has also provided training and advisory services to governments. He also regularly participates in public and media events, most recently on Brexit and its legal, social and cultural significance.



**Prasan Ulluwishewa** completed his LLB/ B Commerce (Accounting) at UNSW and completed his Masters in Law (LLM) at the University of Virginia School of Law with a focus on US commercial and antitrust law in the context of the energy and resources sector. He practiced as a Solicitor at Mallesons Stephen Jaques (now King & Wood Mallesons) with a practice focus on corporate, commercial and competition law in the course of representing clients in heavily regulated industries. Prior to and after this Prasan also served as a Speechwriter and Senior Policy Advisor to two (now former) Premiers of New South Wales and several NSW Government Ministers. He currently lectures in Criminal Law, Torts and Employee Relations Law at Notre Dame and researches and publishes in the field of Construction Law.



**Grégoire de Vogüé**, a graduate of HEC, holds a DESS in Law and Tax from the Sorbonne (Paris I) and CAPA, is the head of the Deloitte / Taj Transfer Pricing team.
